CIRCULAR-3 / 2013

The attention of the Police Hqrs has been drawn to the paragraph No 18 of the Judgment and order passed by the Hon'ble HIGH COURT OF MEGHALAYA in CrI. Revn.P.(SH) No. 34 of 2013 re Superintendent of Police, East Khasi Hills District Versus Shri. Tik Mawlong, S/o (L) Kon Jyrwa of Mawlong and to the paragraph No 14 of the Judgment and order of the said Hon'ble court in the CrI. Revn.P. (SH) No. 35 of 2013 re Superintendent of Police, East Khasi Hills District Versus Shri. Shalak Nongrum S/o Tin Mukhim R/o Kseh Pyndeng . In both these paras the hon'ble High court has directed the Director General of Police, Meghalaya to instruct all the Police Officers and Police Stations to give priority to summon warrant issued by the Court and to submit the report in time so that trial will proceed smoothly without any delay and to remind the police personnel that they are part of the criminal justice system.

All District Superintendents of Police should carefully note the above directions given by the Hon'ble Meghalaya High Court and they must sensitize the officers in charges of Police stations and Outposts and their supervisory officers such as Circle Inspectors, Dy SP/Addl SP/SP in charge of crime to fully ensure that the said Judgment and orders of the Hon'ble High Courts & other Courts issued from time to time are strictly complied with. Those officers who are found not complying with the Court orders should be dealt with sternly departmentally and as per law.


