**CIRCULAR NO. 3/2014.**

It has been brought to my notice that instances of cases for transfer of investigation to CID from the Districts are being recommended by Range Officers routinely on the recommendation of District Superintendents of Police. In most cases, the District Superintendents of Police and Range Officers have also not reviewed the progress of investigation of such cases and cases where investigation has been stalled and no progress made for months are recommended for transfer to CID.


Henceforth, before recommending cases for transfer to CID for investigation, IG/DIG In-charge Ranges will first review the progress of the investigation of such cases without mechanically going by the recommendations of the district Superintendents of Police for transferring the case to CID. On receipt of the recommendation of IG/DIG In-charge of the Range, views and comments will be sought from CID and a final decision will be then be taken at Police Headquarters for transferring the case to CID.
