Henceforth, any invitation extended by the Governor for any function at Raj Bhavan should be treated as a directive and officers should make it a point to respond to the same. Such invitation from Raj Bhavan also has to be accepted and honoured as matter of course, and if the officer happens to be available in the Headquarters, he should invariably make it a point to attend such functions". In case of any compelling reason for inability to attend, prior intimation should be invariably sent to the Principal Secretary to the Governor, indicating the reason for the same, under intimation to the Chief Secretary.




