**SHORT NOTICE INVITING TENDER**

Sealed Tender affixing Non-refundable Court Fee Stamp of Rs. 25 (Twenty-five) only is invited from interested persons/Firms/Dealers for disposal of the condemned Vehicles as shown in ANNEXURE 'A' on as is where is basis. Tender will be received by undersigned upto **1400 hrs** on **27<sup>th</sup> June, 2016** and will be opened on the same day at **1530 hrs** at Police Headquarters, Director General of Police, Meghalaya Shillong in presence of the Tenderers or Representatives if any.

Terms and Conditions

1. Tender should be quoted separately for each item to be accompanied by Earnest Money. Earnest Money as far as practicable should be in form of Deposit at call duly pledged in favour of the Assistant Inspector General of Police (A), Meghalaya, Shillong. Earnest Money in any other recognized form like National Saving Certificates, Fixed Receipt are also acceptable provided they are duly pledged in favour of the Asstt. Inspector General of Police (A), Meghalaya, Shillong.
2. Rate quoted for each vehicle in Tender should be written clearly both in figures and in words any overwriting should be duly attested.
3. Tender should be addressed to the undersigned by designation and not by name. Sealed envelope containing the Tender must be super scribed by words 'Tender for purchase of Condemned Vehicles' and be sent by registered post Deposited in Tender Box in the office of the Director General of Police, Meghalaya, Shillong.
4. The following documents should be attached with Tender, Tender received without the required documents will be summarily rejected.
  - a) Attested copy of Photograph of the Tenderer.
  - b) Earnest Money at 10% of the bid Money be submitted duly pledged in favour of the Director General, Meghalaya, Shillong.
  - c) Up-to-date trading License in terms of KHADC Regulation Act for Non-Tribals and S.T certificate for Tribals.
5. The intending Tenderers may inspect the condemned vehicles as shown in ANNEXURE - 'A' at the location as indicated on any working days from 10.00 hrs to 16.00 hrs.
6. The successful Tenderers shall be intimated and a letter of acceptance will be issued by the undersigned.

7. The accepted price in full will have to be deposited by the successful Tenderers and the vehicle removed at his/their own cost within the date fixed for the purpose by the Department.
8. The undersigned will not be held responsible for any loss or damage of the condemned vehicles, if any, if they are not removed within the specific date.
9. The Earnest Money of the successful Tenderer shall be forfeited to Government if he fails to deposit the accepted price and lift the vehicles within the date fixed for the purpose.
10. The Earnest Money of the unsuccessful Tenderer shall be released after the award of Tender to the successful Tenderer.
