Sealed Tender affixing Non Refundable Court Fee Stamp of Rs.25/- (Rupees twenty five) only are invited for supply of Clothing/uniforms items for the VDP Personnel for the year 2016-17 from manufacturers, authorized agent and dealers sealed tender accompanied with sealed samples will be received by the undersigned on or before **23th September,2016 @1300 hrs**

Tender received will be open on the same day @ **1330 hrs** in presence of the tenderers or their representative. The undersigned reserves the right to accept or reject any tender(s) without assigning any reasons thereof.

The rate of the items should be quoted including all taxes and other charges.

1. Tender must accompanied with:-

- (a) Firms should be registered under Meghalaya Value Added Tax for items to be supplied and proof of Tax Identification Number (TIN) of the firm should be enclosed without which the tender shall be out rightly rejected.
- (b) Attested copies of Valid Trading License in terms of KHADC/JHADC/GHADC for Non-Tribals (Regulation Act 1954) who are required to obtain such License should be enclosed.
- (c) Attested copy of Photograph of the Tenderer should be submitted alongwith Tender.
- (d) An undertaking should be furnished that the supply/work will be done by the contractor/tenderer himself/herself.
- (e) A Financial Stability Certificate from the Deputy Commissioner, 1st Class Magistrate or of a Schedule Bank certifying that the firm/supplier is capable to undertake the supply should be submitted alongwith the tender.
- (f) Attested copy of upto date Tax Clearance Certificate and Professional VAT Clearance Certificate from the concerned Taxation Department should also be enclosed.
- (g) Tenders must be accompanied by Earnest money at the rate of 10% (ten percent) of the total value of article tendered.
- (h) Successful Tenderer will have to deposit Security money @ 10% for tribal contractor & 11% for Non- tribal contractor of the total value before execution of contract.
- (i) Successful Tenderer will have to submit a Contract Agreement.
