Tenders must accompanied with:-

- Firms must register under Meghalaya Value Added Tax for items to be supplied and proof of Tax Identification Number (TIN) of the firm should be enclosed without which the tender shall be out rightly rejected.
- Attested copied of the Valid Trading License in terms of KHADC/JHADC/GHADC for Non-Tribals (Regulation ACT 1954) who are required obtain such Licensee should be enclosed.
- Attested copied of Photograph of the Tenderer should be submitted along with Tender.
- An undertaking should be furnished that the supply/work will be done by the contractor/tenderer himself/ herself.
- A Financial Stability Certificate from the Deputy Commissioner, 1st Class Magistrate or of a Schedule Bank certifying that the firm/supplier is capable to undertake the supply should be submitted along with the tender.
- Attested copied of up to date Tax Clearance Certificate and Professional VAT Clearance Certificate from the concerned Taxation Department should also be enclosed.
- Tenders must be accompanied by the Earnest Money at the Rate of 10 % (Ten percent) of the total value of the article tendered.
- Successful Tenderer will have to deposit Security money @10% for tribal contractor & @ 11 % for Non-tribal contractor of total value before execution of contract.
- Successful Tenderer will have to submit a Contract Agreement.


