1. Tender should be quoted separately for each item to be accompanied by Earnest Money. Earnest Money should be either in Form of (i) Deposit at call (ii) National Saving certificate or (iii) Fixed Deposit Receipt duly pledged in favour of the Assistant Inspector General of Police (A), Meghalaya, Shillong.
2. Rate quoted for each item in Tender should be written clearly both in figures and in words any overwriting should be duly attested.
3. Tender should be addressed to the undersigned by designation, sealed envelope containing the Tender must be superscribed by words 'Tender for purchase of defective items' and be sent by registered post Deposited in Tender Box in the office of the Director General of Police, Meghalaya, Shillong.
4. The following documents should be attached with Tender. Tender received without the required documents will be summarily rejected.
 - a) Attested copy of Photograph of the Tenderer.
 - b) Earnest Money at 10% of the bid Money.
 - c) Up-to-date trading License in terms of KHADC Regulation Act to whom ever it is applicable.
