Dated Shillong, the 28th August, 1996.

No.HPL.176/86/17—In exercise of the powers conferred by the proviso to Article 309 of the Constitution, the Governor of Meghalaya hereby makes the following Rules regulating the method of recruitment and conditions of service of persons appointed to the Meghalaya Police Service, namely. -

1. **Short title and commencement** - (1) These rules may be called the Meghalaya Police Service Rules, 1996

(2) They shall come into force from the date of their notification in the Official Gazette,

2. **Definition** - In these rules, unless there is anything repugnant in the subject or context. -

- (a) "Commission" means the Meghalaya Public Service Commission;
- (b) "Committee" means the Departmental Promotion Committee constituted under Rule 9;
- (c) "Government" means the Government of the State of Meghalaya;
- (d) "Governor" means the Governor of Meghalaya;
- (e) "grade" means either the junior or senior grade of the service referred to in Sub-rule (2) of Rule 4;
- (f) "member of the Service" means a person appointed or deemed to have been appointed under these rules to any post in the service;
- (g) "Rules" means the Meghalaya Police Service Rules;
- (h) "Service" means the Meghalaya Police Service constituted under these rule;
- (i) "Schedule" means the Schedule appended to these rules;
- (j) "Select List" means the select list referred to in Sub-rule (5) of Rule 10 or Sub-rule 4 of Rule 11; and,
- (k) "Year" means a Calendar Year

3. **Constitution of the service** - There shall be constituted a service to be known as the Meghalaya Police Service consisting of the following persons, namely, -

- (a) persons appointed to the Assam Police Service who are allocated to the State of Meghalaya in accordance with the provisions of the Sub-section (1) of Section 64 of the North Eastern Areas (Re-organisation) Act, 1971.
- (b) persons appointed to posts of Deputy Superintendent of Police or other equivalent posts in the Armed Police Battalion through the emergency recruitment made by the Commission as per advertisement No. 15PSC/18/2/73-74 dated 27-3-1974;
- (c) persons otherwise appointed to the Meghalaya Police Service on or after the 21st day of January 1972 but before the commence of these rules; and
- (d) persons appointed to the service in accordance with the provisions of these rules.

4. **Composition of the Service** - (1) The service shall consist of such categories of posts as the Governor may, from time to time, determine.
- (2) The service shall, at the commencement of these rules, consist of the following grades and categories of posts, namely, -
- (a) **Senior Grade** - Additional Superintendents of Police and the 2nd - in - Command of the Meghalaya Police Battalions.
- (b) **Junior Grade** - Deputy Superintendents of Police, Sub - Divisional Police Officers, Assistant Commandants of the Meghalaya Police Battalions.
- (3) Each of the grades referred to in Sub-rule (2) shall form an independent cadre. Members of the lower cadre shall have no claim for appointment to the higher cadre except in accordance with the provisions of these rules.
5. **Status** - The status of members of the service shall be of the Group 'A' Gazetted of the Government.
6. **Strength of the Service** - (1) The strength of the service and the post therein shall be as the Governor may, from time to time, determine.
- (2) At the commencement of these rules, the strength of the service and posts therein shall be as shown in the Schedule.
7. **Method of Recruitment** - (1) Appointment to the Junior Grade of the Service shall be made -
- (a) by direct recruitment on the results of the competitive examination conducted by the Commission; and
- (b) by promotion from amongst confirmed Inspectors of police.
- (2) The proportion of vacancies to be filled up in accordance with clauses (a) & (b) above shall be 50 : 50 respectively,
- Provided that the number of persons recruited under clause (b) above shall not, at any time, exceed fifty per cent of the total strength in that grade of the service.
8. **Recruitment by a competitive examination** - (1) A competitive examination for recruitment to the service shall be held at such intervals as the Governor may in consultation with the Commission from time to time, determine.
- (2) The examination shall be conducted by the Commission in accordance with such rules and syllabus as the Governor may, from time to time, make in consultation with such Commission.
- (3) Of the number of vacancies to be filled up on the result of each examination there shall be reservation for candidates belonging to the Scheduled Castes and Scheduled Tribes in accordance with such orders as the Government may, from time to time, make in this regard.
- (4) On the basis of the result of the competitive examination, the Commission, shall prepare a list of all successful candidates in order of merit, which shall be determined in accordance with the aggregate of marks obtained by each candidate and if two or more candidates obtain equal marks, the Commission shall arrange them in order of their relative merit which shall be determined in accordance with the general suitability of the candidates for appointment to the service. The number of persons to be included in the list shall be as laid down in Part IV of instruction appended to the Meghalaya Public Service Commission (Limitation of Functions) Regulation, 1972 and the list shall be forwarded to the Governor.
- (5) The inclusion of a candidate's name in the list shall confer no right to appointment unless the Governor is otherwise satisfied after such enquiry as may be considered necessary, that the candidate is suitable in all respects for appointment and that such appointment is subject to availability of vacancy.

9. **Departmental promotion Committee.** - (1) For the purpose of appointment by promotion under clause (b) of sub-rule (1) of Rule 7 and under Rule 23, there shall be a Departmental promotion Committee consisting of the following members, namely, -

- (a) Chief Secretary to the Government of Meghalaya. - Chairman
- (b) Special Secretary/Secretary to the Government of Meghalaya, Home (Police) Department. - Member
- (c) Special Secretary/Secretary to the Government of Meghalaya, the Personnel & A.R. Department. - Member
- (d) Special Secretary/Secretary to the Government of Meghalaya, Finance Department. - Member
- (e) Director General of Police, Meghalaya - Member Secretary.

(2) The Committee may invite any other person to attend its meeting as and when considered necessary.

10. **Procedure for preparing the select list.** - (1) At the beginning of each year the Governor shall refer to the Committee the approximate number of vacancies likely to occur in each grade of the service during the year. To enable the Committee to prepare the select lists for promotion to those grades under clause (b) of sub-rule (1) of Rule 7 or under Rule 23, the Governor shall furnish the Committee with the following, documents namely, -

- (a) a list of persons who have been confirmed as Inspectors or in the Junior Grade time scale, as the case may be, and who have completed not less than seven years of continuous service, drawn up in order of seniority and consisting of not more than three times the number of vacancies;
- (b) the character rolls and service records of such persons; and
- (c) any other document and information as may be considered necessary by the Governor or required by the Committee.

(2) The Committee after examining the character rolls, service records and other documents in respect of all such persons shall prepare a list of the persons based on seniority with due regard to individual merits and suitability. The number of persons to be included in the list shall be according to the number of vacancies available at the particular grade and the list shall be forwarded to the Governor.

(3) The names of persons in the list shall be placed in order of preference for promotion. In every case where a junior member is selected in preference to his seniors, the Committee shall record, in writing the reasons for doing so.

(4) For the purpose of promotion under Rule 23, the Governor shall consider the list prepared by the Committee and forwarded to him under sub-rule (2) along with the character rolls and service records and other documents in respect of each person in the list and unless he considers that any change is necessary, approve the list. If the Governor considers it necessary to make any change in the list received from the Committee, he shall inform the Committee of the changes proposed and after taking into account the comments if any, of the Committee, approve the list.

(5) The list as approved under sub-rule (4) shall form the select list for the purpose of promotion under Rule 23.

11. **Consultation with the Commission,** - (1) For the purpose of appointment by promotion under clause (b) of sub-rule (1) of Rule 7, the Governor shall forward the list prepared under Sub-rule (2) of Rule 10 to the Commission along with the character rolls, service records and other relevant documents in respect of each person in the list together with comments, if any.

- (2) The Commission shall consider the list and documents referred to in Sub-rule (1) and such other documents as it may have called for and unless it considers that any change is necessary, approve the list.
- (3) If the Commission considers it necessary to make any change in the list received from the Governor, it shall inform him of the changes proposed and after taking into account the comments, if any, of the Governor approve the said list with or without modification as may in its opinion to be just and proper.
- (4) The list as approved by the Commission either under Sub-rule (2) or Sub-rule (3) shall, when finally approved by the Governor, form the select list for the purpose of appointment by promotion under clause (b) of Sub-rule (1) of Rule 7.

12. **Validity of the Select List -** (1) The select list shall remain in force for a period of one year from the date of approval by the Governor unless its validity is extended by him and where the select list has been finalised in consultation with the Commission, the approval of the Commission shall be obtained :

Provided that such an extension shall be for total period not exceeding six months :

Provided, further, that in the event of any great lapse in the conduct or performance of duties on the part of any person in the select list, the Governor if he thinks fit remove the name of such person from the list and the reasons for doing so shall be recorded in writing. Where the name of such person is borne in the list which has been finalised in consultation with the Commission, the Commission shall be consulted.

- (2) The Committee shall meet once a year to review the select list.

13. **Conditions of Eligibility for appearing at the Competitive Examination -** (1) In order to be eligible to compete at the Competitive examination referred to in Rule 8 a candidate must satisfy the following conditions, namely, -

- (a) he must be a citizen of India;
- (b) he must have attained the age of 21 but must not have exceeded the age of 27 on the first day of the year in which the advertisement for the post is made :

Provided that in the case of Candidates belonging to Scheduled Caste and Scheduled Tribes the upper age limit shall be subject to such relaxation as Government may determines;

- (c) he must hold a Bachelor's degree of any University recognised by the Governor for this purpose;
- (d) on the commencement of these rules, the Universities recognised shall be as given in Schedule II;
- (e) he must pay the fees prescribed by the Commission, and
- (f) satisfy other requirements of the Commission in relation to the examination.

- (2) The decision of the Commission as to the eligibility or otherwise of a candidate for admission to the examination shall be final and no candidates to whom a certificate of admission has not been issued by the Commission shall be admitted to the examination.

14. **Disqualification for appointment to the Service -** (1) No person shall be appointed who, after such medical examination as the Governor may determine is not found to be in sound mental or bodily health or free from any physical defect or infirmity which may render him unfit in the discharge of his duties.

- (2) No person shall be appointed to the service who has been convicted for any offence involving moral turpitude.

- (3) No person, -
- (a) who has entered into or contracted a marriage with a person having a spouse living; or
 - (b) who having a spouse living, has entered into or contracted a marriage with any person, shall be eligible for appointment to the said service:

Provided that the State Government may, if satisfied that such marriage is permissible under the personal law applicable to such person and the other party to the marriage and that there are other grounds for so doing, exempt any person from the operation, to the sub-rule.

- (4) No person who attempts to enlist support for his candidature by any means whatsoever whether direct or indirect shall be appointed to the service.

15. **Appointment to the Service** - (1) Appointment to the service under Rule 7 and Rule 23 shall be made by the Governor and shall be notified in the Gazette of Meghalaya.

- (2) A Person appointed by direct recruitment shall join the post within fifteen days of the date of receipt of the order of appointment, failing which and unless the Governor extends the period, which period shall not in any case exceed three months, the appointment shall be cancelled.

- (3) Subject to the provision of sub-rules (3) and (5) of Rule 8, appointment under clause (a) of Sub-rule (1) of Rule 7 shall be made in the order in which the names appear in the list prepared by the Commission under sub-rule (4) of Rule 8.

- (4) Appointment under clause (b) of sub-rule (1) of Rule 7 shall be made in the order in which the names appear in the select list approved by the Governor under sub-rule (4) of Rule 11.

16. **Probation** - (1) Every person appointed to the service under clause (a) of sub-rule (1) of Rule 7 shall be on probation for a period of two years from the date of his joining the post :

Provided that the period of probation may for good and sufficient reasons be extended by the Governor in any individual case by a period not exceeding two years.

- (2) Such person referred to in clauses (a), (b) and (c) of Rule 3 who have not been confirmed shall be deemed to have completed the period of probation.

17. **Departmental Examinations and Training** - (1) "Every probationer shall, during the period of probation successfully undergo a twelve months course of training at the N.E.P.A., Umsaw (Meghalaya) or in any other Police Academy Training College as the Government thinks fit and successfully qualify at the end of the training conducted by the said institution in accordance with the syllabus having followed at that institution

- (2) A probationer shall also successfully undergo the survey and settlement training and such other trainings as the Governor may from time to time prescribe and shall appear at and pass order prescribed departmental examination conducted by the Commission:

Provided that a member of the service appointed under clause (b) of Sub-rule (1) of Rule 7 who had already completed similar courses of training at the Assam Police College, Dergaon, shall no longer be required to undergo the same training again :

Provided further that the Governor may for good and sufficient reason exempt any other member of the service from under going such training or any part thereof.

18. **Discharge of the Probationer** - A Probationer shall be liable to be discharged from the service or shall be liable to be reverted to his substantive post if -

- (a) he fails to make sufficient use of the opportunities given during the training or otherwise fails to give satisfactory performance during the period of probation : or

- (b) he fails to pass the prescribed departmental examinations unless the Governor permits him to sit for re-examination : or
- (c) on any information received relating to his nationality, age, health, character and antecedents the Governor is satisfied that the probationer is ineligible or otherwise unfit for being a member of the service : or
- (d) he fails to comply with any of the provisions of these rules.

19. **Confirmation - (1)** Confirmation of a member of the service appointed by promotion shall be made in the respective cadre according to his seniority in that cadre and subject to the following conditions, namely -

- (a) that he has served not less than one year in the grade in which he is to be confirmed;
- (b) that he has successfully undergone the prescribed course of training, in any and passed the departmental examination;
- (c) that his performance, judged on the basis of annual confidential report and other relevant records, is satisfactory;
- (d) that no departmental proceeding or enquiry is pending against him, and
- (e) that there is a vacancy available.

(2) Confirmation of a member of the service appointed by recruitment under clause (a) of Sub-rule (1) of Rule 7 shall be made according to his seniority and subject to the following conditions, namely —

- (a) that he has successfully completed the period of probation to the satisfaction of the Governor;
- (b) that he has successfully undergone the prescribed course of training and passed the prescribed departmental examination;
- (c) that he is considered otherwise fit for confirmation; and
- (d) that there is a vacancy available :

Provided that confirmation of a member of the service who is exempted from undergoing or is not given opportunity to undergo the prescribed course of training during the period of probation shall not be held up but such persons when called upon to do so, shall successfully undergo the training failing which he shall be liable to be removed from service.

(3) Notwithstanding anything contained in this rule the Governor may for good and sufficient reasons relax the requirement of clause (b) of Sub-rule (1) or clause (b) of Sub-rule (2) and confirm a member of the service in the respective cadre.

20. **Seniority- (1)** The *inter-se* seniority of the members of the service who originally belonged to the Assam Police Service and appointed before the 21st day of January, 1972 and who were allocated or may be allocated to the State of Meghalaya in accordance with the provision of Sub-section (1) of section 64 of the North Eastern Area (Reorganisation) Act, 1971 shall be as it was under the corresponding grade under the Government of Assam prior to their allocation to the State of Meghalaya.

(2) The *inter-se* seniority of the members of the service appointed through the emergency recruitment referred to in clause (b) of Rule 3 shall be in the order in which their names appeared in the list furnished by the Meghalaya Public Service Commission. Such members shall be junior to all members of the service referred to in Sub-rule (1).

(3) The *inter-se* seniority of members of the service recruited before commencement of these rules shall be in the order in which their names appeared in the merit list prepared by the Commission or the list recommended by the Committee constituted for the purpose of making promotions as the case may be.

- (4) The *inter-se* seniority of members of the service recruited after the commencement of these rules shall be in the order in which their names appeared in the merit list prepared under Sub-rule (4) of Rule 8 or in the select lists approved under Sub-rule (5) of Rule 10 or under Sub-rule (4) of Rule 11 :

Provided that a member of the service appointed by promotion shall be senior to a member appointed by direct recruitment where both appointments fall in the same year.

- (5) If confirmation of any member of the service is delayed such member shall lose his seniority in the cadre *vis-a-vis* such of his Juniors as may be confirmed earlier than him. His original position in that cadre shall, however, be restored on his subsequent confirmation.

21. **Time Scale of Pay** - (1) The time scale pay admissible to a member of the service shall be as shown in Schedule I subject to revision by the Governor from time to time.

22. **Increment** - (1) The first increment admissible to a member of the service in the junior grade time-scale shall accrue on the expiry of one year from the date of his joining the service, but further increment shall be allowed only on his confirmation in the service.

- (2) On confirmation the pay of a member of the service in the Junior grade shall be fixed at such a stage, as if he had been allowed his annual increments but he shall not be entitled to any arrear on account of increments withheld for the periods prior to the date of his confirmation.

- (3) The Governor may withhold, for such time as he may direct, an increment or increments due to a substantive member of the service who failed to pass the departmental examinations within such time as the Governor may, by general or special order, prescribe but the withholding of such increments shall have no cumulative effect.

23. **Promotion to senior grade time - scale** - (1) A member of the service in the junior grade shall be eligible for promotion to the senior grade but no member of the service shall be so promoted unless he has served in the junior grade for a minimum period of seven years and the Governor is satisfied about his ability and character.

- (2) The appointment to the senior grade shall be made by the Governor from the select list referred to in Sub - rule (5) of Rule 10.

24. **Miscellaneous Provision** - Except as provided in these rules, all matters relating to pay, allowances, leave, pension, discipline, and other conditions of service shall be regulated by the general rules framed by the Government from time to time.

25. **Power of the Governor to dispense with or relax any rule** - The Governor may, if he is satisfied that the operation of any of the provisions of these rules causes undue hardship in any particular case or cases or results in any particular post or posts being left unfilled for want of a person possessing the minimum required qualification as specified by these rules may dispense with or relax the requirement of any of these rules to such extent and subject to such conditions as he may consider necessary for dealing with the case in a just and equitable manner or for meeting the exigencies of public interest :

Provided that the case of any person shall not be dealt with in any manner less favourable to him than that provided under these rules.

26. **Interpretation** - If any question arises relating to the interpretation of these rules, the decision of the Government in the Home Department with the approval of Personnel and Administration Reforms Department shall be final.

27. **Repeal and savings** - (1) The Meghalaya Police Service Rules, 1976, the orders or notifications corresponding to and in force immediately before the commencement of these rules are hereby repealed.

- (2) Notwithstanding such repeal anything done or action taken under the rules, orders or notifications so repealed, shall be deemed to have been validly done or taken under the corresponding provisions of these rules.

No.HPL.257/2010/196—In exercise of the powers conferred by the proviso to Article 309 of the Constitution, the Governor of Meghalaya is pleased to make the following Rules further to amend the Meghalaya Police Service Rules, 1996 namely. -

1. Short title and commencement : (1) These Rules may be called the Meghalaya Police Service (Amendment) Rules, 2012.

(2) They shall come into force at once.

2. Amendment of Rule 7 :

In Rule 13 of the Meghalaya Police Service, Rules 1996, in Sub-rule (1), after the existing clause (f), the following proviso shall be inserted namely, -

“(g) The candidates shall have certain minimum physical standards and shall undergo a Physical Efficiency Test (PET) as elaborated below :-.

(i) Minimum Height Requirement :

Male candidates - 157 Centimeter for (ST)
162 Centimeter for others.

Female candidates - 152 Centimeter for (ST)
157 Centimeter for others.

(ii) All Candidates will be required to qualify in 10 (ten) Kilometers race, in 60 (sixty) minutes or less for male and 5 (five) Kilometers race in 35 (thirty five) minutes or less for female candidates”.
