No. PER. 100/90/Pt/6 - In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Meghalaya is pleased to make the following rules to amend the Meghalaya Services (Conduct) Rules, 1990, namely,-

- 1 **Short title and commencement** - (1) These rules may be called the Meghalaya Services (Conduct) (Amendment) Rules, 2015.
(2). It shall come into force at once.
- 2 **Insertion of new rule 20 B** - In the Meghalaya Services (Conduct) Rules, 1990, after Rule 20 A, the following new rule 20 B shall be inserted, namely, -
"20 B - **Membership in any Community based Organization, Association, Traditional Body or Society** :- No member of the service shall, except with the previous sanction of the Government, hold office in a Community based Organization, Association, Traditional Body or Society."
