  - (b) Attested copies of valid Trading License in terms of GHADC for Non-Tribals with required trade to undertake the work (regulation Act 1954) who are required to obtain such license should be enclosed and a scheduled tribe certificate in case of tribals (**Certificate must be issued by competent authority of the state of Meghalaya only**)
  - (c) Attested copy of Photograph of the Tenderer should be submitted alongwith Tender
  - (d) An Undertaking should be furnished that the supply/work will be done by the contractor /Tenderer.
  - (e) Latest financial stability Certificate from the Deputy Commissioner 1<sup>st</sup> Class Magistrate or of a Schedule Bank certifying that the firm/Supplier is capable to undertake the supply should be submitted alongwith the tender.
  - (F) Attested copy of upto date Professional Tax Clearance Certificate should be enclosed.
  - (g) Tender Must be accompanied by earnest money @ Rs. 5000/- (Rupees five thousand) only for both Tribals and Non-Tribals.
