- 1. The tenderers should submit their tender in sealed envelope.
- 2. All tenderers must submit the earnest money deposit amounting to Rs.80,000/- (Rupees Eighty thousand only) in the form of Bank Draft from any scheduled bank in favour of Additional Director General of Police (CID) Cum Nodal Officer CCTNS Project Meghalaya, Shillong payable at Shillong. The EMD of successful tenderer will be converted into security till the complete supply is made and will be refunded without any interest. The EMD of unsuccessful tenderer will be returned after completion of tender process. No tender will be entertained in the absence of EMD.
- 3. In case of failure of supply of lowest rates, earnest money of concerned firm would be forfeited. No changes in the rate will be entertained after the bid accepted.

- 5. The bid to be submitted in an envelope along with complete details/ work specifications as specified in para 4. The rates must be quoted inclusive of all taxes, F.O.R. destination and installation charges.
- 6. On completion of the work and after the supply / installation of hardware, a team under the leadership of Dy.SP (SCRB/CCTNS) from CCTNS (Crime and Criminal Tracking Network and Systems) Cell PHQ Shillong, will undertake an inspection of all the sites. Thereafter, they will submit a report of the same to the undersigned. Payment will be released as per the report submitted by the team and only after successful completion of the work specification mentioned in para 4. Submission of completion Report and Satisfactory Report to the Director, SCRB Meghalaya, Shillong to be sealed and signed by the concerned authority of the supplier. Rates quoted should be in one bulk for all the 3 (three) sets.
- 7. Complete operation Manual should be submitted to this Department and proper operation training to be given to concerned person of this Department. ST Certificate / Trading License as applicable to be furnished by the successful bidder at the time of issue of work Order.

- 8. The work undertaken and installed items must be warranted with on-site support facilities from the date of installation for a period of 3 years minimum..
- 9. All received offers would be valid for a period of 90 days from the date of submission of tender. No basic price change will be entertained during the period.
- 10. It is mandatory that the above noted work / supply to be started within 7 days from the date of issue of work order, otherwise penalty_of late delivery @ 1% of the total cost will be imposed per week.
- 11. Successful bidder to submit timeline for completion of work on receiving work order.
- 12. Sealed tender along with demand draft of EMD may be sent to the undersigned upto 3.00

 PM on 2nd September 2021. These bids will be opened on the same day at 4.00
