(c) Attested copy of Photograph of the Tenderer should be submitted alongwith Tender

(d) An Undertaking should be furnished that the supply/work will be done by the contractor /Tenderer.

(e) Latest financial stability Certificate from the Deputy Commissioner 1<sup>st</sup> Class Magistrate or of a Schedule Bank certifying that the firm/Supplier is capable to undertake the supply should be submitted alongwith the tender.


